## 2024 - 2025 Agricultural & Environmental Education Grant

Thank you for your interest in applying for the Flint River Soil and Water Conservation District's Environmental & Agricultural Education Grant. We appreciate your time in developing this application and look forward to reading your proposed project for your classroom. Please review the following criteria prior to submitting your application:

## **Grant Criteria:**

- 1. Grant requests are to promote and support natural resources/environmental or agricultural education.
- 2. Grant funding requests may include, but are not limited to: tools, books, software, lab equipment, field trips, development of natural resource areas such as outdoor gardens or nature trails, etc.
- 3. Total amount requested cannot exceed **\$1,000.00**, although the total project budget may exceed \$1,000.00 with additional match funding sources
- 4. Grantees are required to meet with Flint River SWCD after the project has been completed.
- 5. Eligible grantees are **formal and non-formal educators** from any school, grade levels Pre-K 12<sup>th</sup>, within the following counties: **Baker, Calhoun, Decatur, Dougherty, Early, Grady, Miller, Mitchell,** and **Seminole**.
- 6. Grantees that have the capability to provide in-kind or matching contributions, please provide that information on page 2 of the application form.
- 7. The awarded project must be implemented by May 2, 2025.
- 8. The following two pages must be filled in completely and submitted to the Flint River SWCD by **April 1, 2024**.
- 9. Grantees must submit a final report to Abby Davis at abby@flintriverswcd.org, on or before May 2, 2025. This report will summarize the project and discuss the impact it had on students, as well as include photos, invoices and/or receipts. If grantees will not complete project activities before this time, notice must be given by February 14, 2025 to discuss project budget adjustments or extension.
- 10. Please note that this is a competitively awarded grant, and if you are not selected as a recipient this year, you are welcome to apply again in the future if the Flint River SWCD is able to offer the opportunity.

Please note that projects will be selected by the District's Executive Committee, who will only see the second page of the application. Any mention of teacher name, school name, or other identifying information will be redacted to ensure a fair award determination process.
